



## TRUST PAYMENT NOTICE IN RESPECT OF THE DISTRIBUTION FOR THE PERIOD ENDED 30 SEPTEMBER 2023

Newmark REIT Management Limited (**NRML**), as the responsible entity of Newmark Property REIT (the **Trust**) declares that the Trust is a withholding managed investment trust for the purposes of Subdivision 12-H of the Taxation Administration Act 1953 (Cth) (the **Act**), in respect of the distribution period ended 30 September 2023.
